- 2. The bidder should have successfully completed/executed any one of the following during last seven (07) years ending last day of the month previous to one in which bids are invited -

- 4. The bidder should have tested/got tested Transformer Oil as per IEC60296 at a laboratory accredited by national/international accreditation agency (like NABL Labs/IIT Labs/ERDA Labs/CPRI Labs) not earlier than three years on date of bid opening.
- 5. The bidder should have in-house oil testing lab for testing oil as per IEC60296.
- 6. The bidder should have valid PAN and Sales Tax registration.
