	The agency must have a CHA license registered at Mumbai/Nhava Sheva Customs with office setup at Mumbai (Qualified CHA licensee with requisite custom/port/dock pass for air/sea port at Mumbai and sufficient qualified staff at least one for each port). And should submit documents (gate pass from custom/dock/port) in support of this.	
3	Document to be submitted by Vendor in support of meeting QR	<ul style="list-style-type: none"><li>a. Valid CHA license copy, registered at Mumbai/Nhava Sheva Custom</li><li>b. Gate pass from custom/dock/port of qualified staff from at least one for each port.</li></ul>
4	Additional Documents to be submitted	<p>In addition to the documents required in support of meeting Technical Qualifying Requirements as stated above, following documents are required to be submitted by the Applicants applying for enlistment: -</p> <ul style="list-style-type: none"><li>i. Three POs with BOQ of the highest executed values of similar work during previous five years from the date of application and Copy of Completion Certificate /RA Bill/Final Deviation Statement from the concerned client in support of successful execution of work against each of the POs to be submitted.</li><li>ii. Audited balance sheet including Profit &amp; Loss statement for the previous three completed financial years reckoned from the date of application. In case where the audited results of the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant may be considered acceptable.</li><li>iii. NSIC / SSI / MSME/Udyam registration certificate.</li><li>iv. PAN and GST registration certificate.</li><li>v. Any other documents in addition to the above which the applicant wants to submit.</li></ul>
