1	Brief description of work	Hiring of 100 Tonne or higher capacity mobile crane services.
2	Technical requirements	<p>a. The offered crane shall have the capacity of 100 Tonne or higher which shall not be older than 07 years (registration date) & also have the telescopic boom length of 45 meters or higher.</p> <p>b. The offered crane must be having a lifting capacity of 34 MT or higher at radius of 8 meter with lifting hook height of 25 meter. The offered crane must be having a lifting capacity of 11 MT or higher at radius of 17 meter with lifting hook height of 12 meter.</p> <p>c. In case 100 Tonne crane is not able to meet the said requirement, higher capacity crane shall be offered by the contractor.</p>
3	Additional Documents to be submitted	<p>In addition to the documents required in support of meeting Technical Qualifying Requirements as stated above, following documents are required to be submitted by the Applicants applying for enlistment:-</p> <p>i. Three POs with BOQ of the highest executed values of similar work during previous five years from the date of application and Copy of Completion Certificate /RA Bill/Final Deviation Statement from the concerned client in support of successful execution of work against each of the POs to be submitted.</p> <p>ii. Audited balance sheet including Profit & Loss statement for the previous three completed financial years reckoned from the date of application. In case where the audited results of the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant may be considered acceptable.</p> <p>iii. NSIC / SSI / MSME/Udyam registration certificate.</p> <p>iv. PAN and GST registration certificate.</p> <p>v. Any other documents in addition to the above which the applicant wants to submit.</p>
